

"Terms & Conditions" for entering into rate contract for supply of CL/FMFL/IMFL and Beer to CSMCL Raipur by C.S.1B,FL10A and FL10B licensees for the year 2023-24

1. The offers should be sent in sealed covers with superscript " Rate Offer for CL/FMFL/IMFL/BEER/2023-24" and addressed to the Managing Director, Chhattisgarh State Marketing Corporation Ltd., Aabkari Bhavan, Labhandi, Chhokra Nala, Raipur 492012 so as to reach on or before 01:00 PM on 21/03/2023
2.
 - (a) Offer shall be accompanied by a bank draft for an amount of Rs. 59,000/- (50,000 + 18% GST) as registration fees drawn in favour of The Managing Director, Chhattisgarh State Marketing Corporation Ltd. payable at Raipur. It shall be applicable for any new C.S.1B, FL10 A/B license only. Those already registered need not to pay.
 - (b) A bank draft for an amount of Rs. 10,00,000/- as Security Deposit drawn in favour of The Managing Director, Chhattisgarh State Marketing Corporation Ltd. payable at Raipur should be submitted along with the offer by each FL10 (A)/FL10 (B) Licensee.
 - (c) A bank draft for an amount of Rs. 25,00,000/- as Security Deposit drawn in favour of The Managing Director, Chhattisgarh State Marketing Corporation Ltd. payable at Raipur should be submitted along with the offer by each C.S.1B Licensee.
 - (d) Offers which do not satisfy the conditions laid down in this document are liable to be rejected and security amount will be refunded.
3.
 - (a) The offers may be submitted only by the distillers holding C.S.1 B license for CL; FL10 (A) and FL10 (B) license holders of the Department of Excise, Chhattisgarh . C.S.1 B licensee shall be liable to obtain C.S.1 license with regard to each storage ware - house in the State from Department of Excise, Chhattisgarh.
 - (b) Separate offers shall be presented for Country liquor and Foreign liquor in case of any supplier having C.S.1B (Annexure 'E') and FL10(B) license Annexure 'D'.
 - (c) The offers shall be made in the enclosed application format . (Annexure.- 'A').
 - (d) The licensee shall also submit the duly signed Terms and Conditions of Rate offer.
 - (e) All the above will form part of Agreement of the offer.
 - (f) Annexure 'D' and Annexure 'E' should also be submitted in USB Flash drive in a Sealed Cover.



B. Security Deposit

- 2.8 The C.S.1 B/FL10A/ FL10B licensee has to submit security deposit for each label and security deposit shall be Rs. 10,000/- per label, which shall be paid by bank draft from any nationalized bank or scheduled bank, drawn in favour of Managing Director, Chhattisgarh State Marketing Corporation Limited. Security deposit shall not be accepted in any other form. If demanded, be above amount shall be refundable only after completion of all the auditing of the concerned year. In case of the labels for which the security deposit has been provided for 2021-22, in previous years details of the deposition is to be mentioned.

C. Packing of Stock

- 2.9 The Seller shall ensure that the Stock supplied is adequately and properly packed to prevent any loss, damage or deterioration of the contents during transit.
- 2.10 All damages and breakage of the Stock supplied to the Purchaser on account of defective and improper packing or on account of any manufacturing defect in the contents or on improper storage in godowns/warehouses shall be to the account of the Seller.

D. SUPPLY

- 2.11 The C.S. 1 B/FL10A/ FL10B licensee shall affix at his/ its own cost, hologram stickers as prescribed by the Excise Commissioner, Chhattisgarh, Raipur on each bottle of CL/FMFL/IMFL/Beer. The hologram stickers are to be supplied by the office of Excise Commissioner, Raipur at the rate fixed by the Excise Commissioner.
- 2.12 The IMFL which is manufactured in Chhattisgarh and falling in 1st and 2nd duty slab which has maximum sale and the country liquor will be supplied in glass bottles. A minimum of 25 % of the total stock supplied in a month, shall be done in new fresh glass bottles.
- 2.13 The corporation shall issue Stocking order for supplies based on the stock requirements considering the quantity held and the monthly sales trend of stock of C.S.1B/ FL10A/ FL10B licensee.
- 2.14 The consortium of F.L. 10A/B licensee shall supply liquor by transporting Foreign liquor from the godowns/warehouse of Chhattisgarh State Beverages Corporation Limited to the retail shops by their own vehicle. The transportation rate will be Rs. 25 / - (Without GST) per case. This rate will be not a part of landing price of rate offer.

The vehicles used for transport must be equipped with sealed containers and digital locks.

The separate bill related to transportation expenses will be presented to CSMCL monthly by the consortium of F.L.10A/B licensee, Which would be paid by CSMCL after 5th of every month. Expenditure of wear and tear in the transportation of foreign liquor from the godowns of Chhattisgarh State Beverages Corporation Limited to the retail shops of ~~CSMCL~~/Foreign liquor shall be borne by the consortium of F.L.10A/B licensee.

Note:-

1. Only 01 consortium of F.L.10A/B for transporting of liquor will be allowed. This consortium will take approval from the CSMCL.
2. For any delay/ damage to CSMCL the licensee F.L.10A/B of the consortium will be held liable and penalty will be imposed equivalent to the loss to CSMCL.
3. Expenditure of wear and tear in the transportation of liquor would be calculated by the RSP.
4. The rate of transportation will be quarterly reviewed by CSMCL and will be revised as per prevailing fuel rates.

F. Dispatch Advice

- 2.15 It shall be the obligation of the Seller to communicate the following particulars to the designated godown/ warehouse within 24 hours from the date of dispatch of the Stock;
- (a) Stocking Order No. and Date.
 - (b) No. of Cases dispatched and mode of dispatch.
 - (c) Other relevant particulars necessary to ensure delivery of Stock at the designation.
 - (d) Fill all required detail of dispatch note online in **CSBCL** Portal (<https://csbc.cg.nic.in>), and then only the consignment vehicle will be received and will get unloaded.
 - (e) Attach the dispatch note as mentioned in (d) above, along with invoice.

G. Delivery Schedule

- 2.16 The C.S.1 B/FL10A/ FL10B licensee shall be responsible to ensure that the supply of the Stock is made as per the delivery schedule indicated in the Stocking Order placed for the supply.
- 2.17 The Stock should be delivered during the working hours of the day and on working days only, at the specified destination.
