- 1.3 'Case' means 6,9,12 Nos. of 1000 ml, 3,6,12 Nos. of 750 ml,6,12Nos. of 700 ml, 12 Nos. of 500ml, 24 Nos. of 375 ml,24 Nos. of 330 ml,24 Nos. of 275 ml and 48 Nos. of 180 ml of Sprit.

12 Nos, 20nos, of 650ml, 24Nos.325/330/355ml/500ml/325ml\_can, 330ml\_can, 500ml\_can of malt.

- 1.4 **'Delivery'** means the delivery of stock made by the C.S.1B/FL10A/FL10B licensee at the warehouse and depots of CSBC;
